

ANNEXATION NOTICE

The Town of Orchid is proposing to annex certain unincorporated property contiguous to the Town boundaries. The area proposed for annexation is shown on the map below and is generally described as the Marsh Island area. The complete legal description by metes and bounds and the annexation ordinance (Ordinance No. 2010 - 04) can be inspected by the public and obtained from the office of the Orchid Town Clerk at 7707-3 US Highway 1, Vero Beach, Florida, 32967.



Enlargement of Proposed Annexation Areas

The title of Ordinance No. 2010 - 04 is as follows:

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF ORCHID, FLORIDA, PROPOSING TO ANNEX REAL PROPERTY, CONTAINING 44.65 GROSS ACRES MORE OR LESS, AND GENERALLY KNOWN AS MARSH ISLAND AREA BEING CONTIGUOUS TO THE BOUNDARIES OF THE TOWN OF ORCHID, MORE PARTICULARLY AND LEGALLY DESCRIBED ON EXHIBIT "A," ATTACHED HERETO AND FULLY INCORPORATED HEREIN BY THIS REFERENCE; PROVIDING FOR THIS ORDINANCE TO BE SUBMITTED TO A VOTE OF THE REGISTERED ELECTORS OF THE MARSH ISLAND AREA PROPOSED TO BE ANNEXED; PROVIDING FOR THE AMENDMENT OF THE ORCHID CHARTER, APPENDIX A, TO INCORPORATE THE REAL PROPERTY INTO THE TOWN BOUNDARIES IF THE ANNEXATION IS APPROVED BY MAJORITY VOTE OF SAID REGISTERED ELECTORS AT A DULY HELD REFERENDUM; PROVIDING FOR THE FILING OF THE REVISED ORCHID CHARTER WITH THE DEPARTMENT OF STATE UPON SAID APPROVAL; PROVIDING FOR REPEAL OF PRIOR INCONSISTENT ORDINANCES AND RESOLUTIONS, SEVERABILITY, AND PROVIDING FOR A CONTINGENT EFFECTIVE DATE.

Two public hearings on the proposed annexation will be held by the Orchid Town Council. The first on November 15, 2010, beginning at 9:00 am, or as soon thereafter as may be heard, and the second on November 19, 2010, beginning at 9:00 am, or as soon thereafter as may be heard, both at the Orchid Island Golf and Beach Club, Orchid, FL 32963. Any member of the public may appear at this meeting to speak regarding this Ordinance. If a person wishes to appeal the decision made by the Town Council, that person will need a record of the proceeding and for such purpose may need to ensure that a verbatim record of the proceedings is made, which include the testimony and evidence upon which the appeal is based.
